
Drug Checking in Fraser Health

August 2025



Key findings

- In August, 341 drug checks were performed by FTIR drug checking services in the Fraser Health region (16 access points).
- The percentage of opioid samples testing positive for benzodiazepines by FTIR and/or test strip increased to **64.1**% in August, the highest of any region.
- The percentage of unregulated opioids containing benzodiazepines in concentrations high enough to be detectable by FTIR (>5%) reached a record high of **58.4**% in August. Desalkylgidazepam was most common, followed by nifoxipam, which tripled in detection from the previous month.
- We note there has been an uptick in samples containing carfentanil since the beginning of the year. In August, carfentanil was detected by FTIR in **2 opioid samples**. The true number is expected to be higher, as it is usually found in concentrations below the FTIR detection limit (<5%) via secondary testing.
- Among the subset of opioids sent for secondary testing with Paper-Spray Mass Spectrometry (n=49), medetomidine was detected in 31 samples, carfentanil in 16 samples, and xylazine in 4 samples.






Fentanyl analogs detected in unregulated opioids, past 6 months



- In August, fluorofentanyl remained the most common opioid detected by FTIR, detected in 60.5% of all unregulated opioids tested (112 of 185 samples).
- There has been an uptick in samples containing carfentanil since the beginning of the year. In August, carfentanil was detected by FTIR in 2 opioid samples.
- The true number of samples containing carfentanil is expected to be higher than what is observed by FTIR, as it is usually contained in concentrations below the detection limit (<5%). Please see the Secondary Testing section of this report for more information.




Percentage of opioids testing positive for benzodiazepines, past 6 months



- During the month of August, 64.1% of expected opioid samples tested positive for benzodiazepines in the Fraser Health region (123 samples of 192 checked).
- Opioid samples are checked for benzodiazepine-positivity using BTNX test strips and the FTIR spectrometer.

Benzodiazepines detected in unregulated opioids, past 6 months




- In August, benzodiazepines were detected by FTIR in 58.4% of all unregulated opioid samples (108 of 185), indicating their presence in higher concentrations (>5%).
- Desalkylgidazepam was most common (51 samples), followed by nifoxipam, which tripled in detection from the previous month (33 samples).
- We are continuing to monitor novel benzodiazepines that emerged at the beginning of the year: nifoxipam, as mentioned above, and ethylbromazolam, detected in 3 samples in August.



Components detected in stimulants


Components in methamphetamine (N=19)



Components in cocaine (N=11)








PSMS Secondary Testing Results Summary

A subset of samples were sent for secondary testing provided by Substance at the University of Victoria, using Paper-Spray Mass Spectrometry (PSMS). PSMS is a highly sensitive technology, and can detect components in samples below the detection limit of the FTIR (<5%). Below is a summary of all active components detected in opioid samples sent in confirmatory testing. For more information about Substance please visit their website.

About this data

Data represented in this report is collected from our partner sites across the province using Fourier Transform Infrared (FTIR) spectrometry in combination with BTNX fentanyl test strips and benzodiazepine test strips when applicable. We note the FTIR spectrometer has a detection limit of approximately 5% concentration (McCrae, 2019).
